- 1. EMPTY CLOSETS, DRESSER DRAWS, ALL CLOTHING, ALL LINEN AS WELL AS BEDDING, SHEETS AND OTHER ITEMS IN THE INFESTED ROOM. THIS WILL ALSO INCLUDE WINDOW TREATMENTS (CURTAINS). ALL MUST BE WASHED IN HOT WATER AND DRIED, OR AT LEAST PLACED IN A DRYER AS HEAT WILL KILL BED BUGS. AFTER YOU MAY PLACE THEM IN A TIGHT PLASTIC BAG.
- 2. REMOVE ALL ITEMS FROM UNDER THE BED SO WE MAY HAVE ACCESS TO THE BED FRAME FOR TREATMENT. IF YOUR MATTRESS IS LOCATED ON THE FLOOR, IT MUST BE TREATED WITH LABELED INSECTICIDES AND PLACED INSIDE OF 2 PLASTIC ZIP TIGHT MATTRESS COVERS AFTER TREATMENT. THE BOX SPRING MUST BE TREATED AND PLACED IN 2 BAGS PLASTIC ZIP LOCK BAGS AS WELL. IT SHOULD THEN BE PLACED ON A BED FRAME, AND NOT RELOCATED TO THE FLOOR. ALL ITEMS, TOYS AND **OBSTRUCTIONS MUST BE REMOVED FROM CLOSETS IN** ROOMS WHERE INFESTATION IS TAKING PLACE.
- 3. ANY ITEM REMOVED FROM THE INFESTED AREA MUST BE VACUUMED AND INSPECTED BEFORE TRANSPORT TO ANOTHER ROOM IN THE HOME. THIS WILL PREVENT THE SPREAD OF BED BUGS TO ANOTHER PART OF THE HOUSE OR BUILDING.
- 4. REMOVE ALL PICTURES, POSTERS AND DRAWERS FROM THE DRESSERS. ALL THE FURNITURE IN THE ROOM MUST BE MOVED FROM THE WALL AREA SO ACCESS FOR TREATMENT CAN BE GAINED. COMPUTERS, TELEVISIONS, WIRES, AND ELECTRICAL DEVICES MUST ALSO BE REMOVED FOR PROPER TREATMENT.
